Formation of a new company in Europe

#### Option no. 1 - Registration in the Name of Shareholders:

- You choose the name of the company.
- You tell us who is going to be the company president and shareholder(s).
- We prepare all the documents.
- The shareholders come to Poland and we register a company together.
- The company director provides a signature authenticated by notary or consul.
- We register the company at KRS, VAT, EU-VAT, REGON, open bank accounts, etc.
- You can start trading.

The option is used when shareholders can come to Europe.



#### Option no. 2 - Fully Remote Registration in the Name of Shareholders:

- You choose the name of the company.
- You tell us who is going to be the company president and shareholder(s).
- 3. We prepare all the documents.
- The shareholders provide us with a power of attorney from a notary public, authorizing us to form a company on their behalf.
- 5. We establish a company in the name of shareholders and on their behalf.
- Making an identity Verification in Notary if needed.
- 7. We register the company at KRS, VAT, EU-VAT, REGON, open bank accounts, etc.
- 8. You can start trading.

The option is used when the client does not want to come to Europe immediately.

- Limited Joint-Stock Partnership (Spółka Komandytowo-Akcyjna S.K.A.)

### 1.Limited Company – LTD (Spółka z ograniczoną odpowiedzialnością – Sp. z o.o.)

#### Main features:

- Characteristics of this entity are analogical to the USA's LLC.
- There are no restrictions on foreign shareholders.
- There is a need for only one board member (Prezes Zarządu Board Director).
- · Supervisory Board is optional however in some cases useful.
- Minimum share capital to be fully paid up is (1200 EUR or 1600 USD or 1000 GBP equivalent).
- Shareholders have limited liability for company's debts

#### 2. Joint-Stock Company (Spółka akcyjna – S. A.)

#### Main features:

- Characteristics of this entity are analogical to the USA's Inc.
- There are no restrictions on foreign shareholders.
- There is a need for only one board member (Prezes Zarządu Board Director).
- There is a need for a Supervisory Board.
- Minimum share capital to be fully paid up is (approx. 24 000 EUR or 32 000 USD or 20000 GBP equivalent).
- Shareholder have limited liability for company's debts

### 3. Registered Partnership (Spółka Jawna – Sp.J.)

#### Main features:

- Characteristics of this entity are analogical to the USA's General Partnership.
- There are no restrictions on foreign partners.
- All the partners are entitled to represent the partnership.
- All the partners have full joint liability for company's debts. However subsidiarity rule is a principle.
- Partner does not need to be a natural person.

### 4. Limited Liability Partnership - LLP/LLC (Spółka Komandytowa - Sp. K.)

#### Main features:

- Characteristics of this entity is analogical to the USA's Limited Partnership.
- A company must have at least one General Partner fully liable for debts and at least one Limited Partner with limited liability.
- There are no restrictions on foreign partners.
- Only General Partners are entitled to represent the partnership.
- There is no minimum capital.
- Both General Partner and Limited Partner do not have to be natural persons.
- There is a freedom to determine the profit sharing relationship between partners.

### 5. Limited Joint-Stock Partnership (Spółka Komandytowo-Akcyjna – S.K.A.)

#### Main features:

- This partnership is a hybrid between Partnership and Joint-Stock company.
- Characteristics of this entity are analogical to Germany's Kommanditgesellschaft auf Aktien (KGaA)
  or France's Société en commandite par actions (SCA) or Belgium's Commanditaire vennootschap op
  aandelen (CVA).
- A company must have at least one General Partner fully liable for debts and at least one shareholder with limited liability.
- There are no restrictions on foreign partners.
- Only General Partners are entitled to represent the partnership.
- General Partner does not have to be a natural persons.







- The minimum share capital is (approx. 12 000 EUR or 16 000 USD or 10 000 GBP)
- There is a freedom to determine the profit sharing relationship between partners and shareholders.

# Residence Card for a foreigners (Temporary Residence Permit)

A residence card is a document enabling a foreigner to stay on the territory of Europe. While the visa is issued most often by the consulate in the country of origin of the foreigner, the residence card is issued by the competent Voivode.

If the foreigner has a residence card, he does not have to apply for a visa anymore.

Obtaining a residence card is a complicated procedure that takes at least 4-5 months.

When considering the case, all documents attached to the application are verified very carefully.

That is why it is so important that the card application is submitted correctly.

Errors in the application, providing false information, attached incomplete documents may result in prolongation of official proceedings for up to several months. That is why it is worth using our help, avoiding mistakes at the beginning of the procedure,

We have already helped many foreigners to obtain a temporary residence card.

We have experience in handling the affairs of employees, students, international marriages, and many other atypical who have received positive decisions based on other circumstances.

- Do you know that an application for a card should be submitted not later than on the last day of legal stay?
- Did you know that providing false data in the card application results in a refusal?
- Do you know that in the case of a refusal, there are circumstances in which it is possible to change the Voivode's decision within 7 days if the appeal is filed immediately with the missing documents?
- Do you know that if the application is submitted on time, you will receive a stamp in your passport confirming your legal
- stay during the proceedings, even if your current visa / card expires in the meantime?
- Did you know that improperly conducted proceedings for issuing a residence card can take many months?
- Do you know that by cooperating with us at any time you can find out at what stage is your case
  in the office, can you come and see the documents we receive from your office?

#### Obtaining a residence card takes place in two stages:

- 1) Obtaining a decision to reside for a fixed period (document containing information on the legal basis for)
- Obtaining a residence card (residence card) it is released about 4-5 weeks after getting a residence decision)
